- (1) (a) A summary of the principal terms of the Pre-IPO Share Subscription Plan (the "Plan") is set out in the prospectus of the Company dated 26 May 2008. (b) Due to the resignation of three participants of the Plan, 19,614,200 Plan shares which may be issued pursuant to the Plan are no longer required to be issued.

 (c) Due to the expiry of the subscription period for the first tranche of the Plan shares which subscriptions were required to be made by the participants of the Plan on or before 8 June 2009, 17,253,200 Plan shares which may be issued pursuant to the Plan are no longer required to be issued. Details of such matter were set out in the Company's announcement dated 8 June 2009.
- (2) 301,314,541 new ordinary shares were issued on 10 July 2009 pursuant to the DZJ Acquisition Agreement dated 13 January 2009 and as supplemented by the DZJ Supplemental Agreement dated 3 July 2009 (together the "Agreements"). A remaining balance of 92,270,000 shares will be issued according to the Agreements. The DZJ Acquisition was approved by written shareholder's approvals dated 13 January 2009 and 3 July 2009 in lieu of holding general meetings under Rule 14.44 of the Listing Rules. Details of which are stipulated in the Company's announcements dated 14 January 2009 and 3 July 2009 respectively and the circular dated 4 February 2009.
