(1) (a) A summary of the principal terms of the Pre-IPO Share Subscription Plan (the "Plan") is set out in the prospectus of the Company dated 26 May 2008. (b) Due to the resignation of two participants of the Plan, 15,088,000 Plan shares which may be issued pursuant to the Plan are no longer required to be issued.

(c) Due to the expiry of the subscription period for the first tranche of the Plan shares which subscriptions were required to be made by the participants of the Plan on or before 8 June 2009, 17,253,200 Plan shares which may be issued pursuant to the Plan are no longer required to be issued. Details of such matter were set out in the Company's announcement dated 8 June 2009.

(2) 393,584,541 new ordinary shares may be issued pursuant to the DZJ Acquisition Agreement dated 13 January 2009. The DZJ Acquisition was approved by a written shareholders' approval dated 13 January 2009 in lieu of holding a general meeting under Rule 14.44 of the Listing Rules.

(3) 421,621,622 new ordinary shares may be issued pursuant to the Yue Yuen Subscription Agreement dated 13 January 2009. The Yue Yuen Subscription Agreement was approved by shareholders at the Special General Meeting on 27 February 2009.

Details of (2) and (3) are stipulated in the Company's announcement dated 14 January 2009 and the circular dated 4 February 2009.
