**POLL RESULTS OF THE ANNUAL GENERAL MEETING  
HELD ON 24 MAY 2024**

All the Proposed Resolutions as set out in the 2024 AGM Notice were duly passed by the Shareholders by way of poll at the 2024 AGM.

At the annual general meeting of Pou Sheng International (Holdings) Limited (the “Company”) held on 24 May 2024 (the “2024 AGM”), all the proposed resolutions (the “Proposed Resolutions”) as set out in the notice of the 2024 AGM dated 23 April 2024 (the “2024 AGM Notice”) were duly passed by the holders of the Company’s ordinary shares (the “Shares” and the “Shareholders”, respectively) by way of poll. The Company’s Hong Kong branch share registrar and transfer office, Computershare Hong Kong Investor Services Limited, was appointed and acted as the scrutineer for vote-taking at the 2024 AGM.

As at the date of the 2024 AGM, there were 5,326,179,615 issued Shares, being the total number of Shares entitling the Shareholders to attend and vote for or against the Proposed Resolutions at the 2024 AGM. There were no Shares entitling the Shareholders to attend the 2024 AGM and abstain from voting in favour of any of the Proposed Resolutions pursuant to Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “Listing Rules”). Except for Computershare Hong Kong Trustees Limited, as the trustee of the share award scheme of the Company holding 143,668,760 unvested Shares, representing approximately 2.7% of the total number of Shares in issue, which was required to abstain from voting on matters that require approval of the Shareholders of the Company under Rule 17.05A of the Listing Rules, no other Shareholder was required under the Listing Rules to abstain from voting. No parties have stated in the Company’s circular dated 23 April 2024 their intention to vote against or to abstain from voting on any of the Proposed Resolutions at the 2024 AGM.

All directors of the Company, namely Mr. Yu Huan-Chang, Mr. Hu, Chia-Ho, Mr. Chen, Li-Chieh, Ms. Tsai Patty, Pei Chun, Mr. Li I-nan, Mr. Chen, Huan-Chung, Mr. Feng Lei Ming and Mr. Liu, Hsi-Liang, attended the 2024 AGM.
